**Why India?** India is the world's fastest growing free-market democracy, and it offers opportunities to all types of businesses, in particular U.S. companies. The Indian market, and its one billion plus population, presents lucrative opportunities for U.S. exporters with the right products/services and commitment. Did you know:

- In 2005, two-way merchandise trade between India and the U.S. reached a high of \$26 billion, with U.S. merchandise exports to India reaching nearly \$8 billion, almost double our exports in 2002?
- India's transportation, energy, environmental, health care, high tech, and defense sector demands for equipment and services will exceed tens of billions of dollars in the next five to ten years?
- Approximately 200 million Indians have increasing purchasing power, creating a growing middle class of consumers?
- Alabama exports to India reached \$146.8 million for the year 2005, representing an increase of over 39% from the previous year?

### **Alabama Trade Mission to India**

The Alabama Development Office and the Export Alabama Trade Alliance, including NAITA and the Madison County Commission, is organizing a **Trade Mission to India, February 9-16, 2007**. Stops include Mumbai, Bangalore and New Delhi. The mission is aimed both at companies interested in entering the Indian market and those wishing to increase their business in India.
